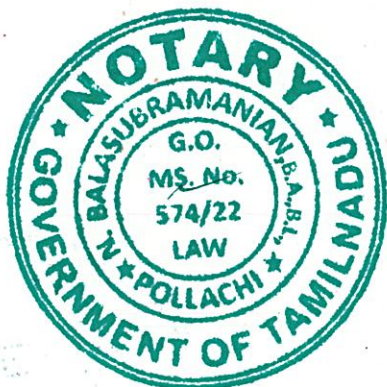

I, **Dr.M.Manickam** Chairman, of **Nachimuthu Industrial Association**, do hereby solemnly affirm and declare/undertake as under :

1. That I am the Chairman of the **Nachimuthu Industrial Association**, and am duly aware and competent to swear the present affidavit.
2. That all moveable and immovable assets of the institution(s) shall be used only for the purpose of conducting academic activities, promotion of research, and related administrative requirements of the Institution Deemed to be University.

7. That the interest accrued on the corpus fund shall be used only for the purpose of further development of the Institution deemed to be the University.
8. That the proposed Deemed to be University shall abide by all the provisions of the UGC Act, 1956 and the rules and regulations made under the said UGC Act including the UGC (Institutions Deemed to be Universities) Regulations 2023.

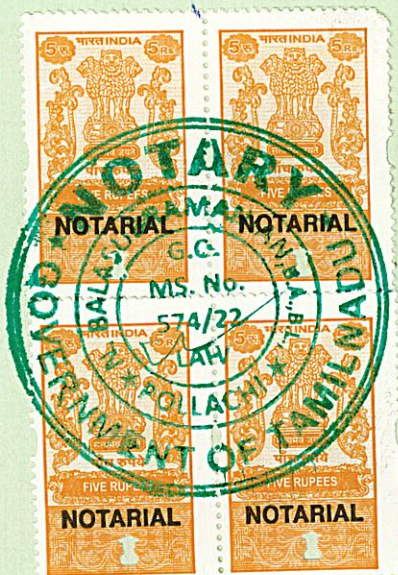
